CONSTITUTION

TAJDEED-E-NIZAM PARTY

VISION:

Its aim is to build a society in conformity with injunctions, orders and advises of “**Rub- ul- Aalameen**” as revealed in the Holy Quran, and the Sunnah of “**Khatim un Naydeen Hazrat Muhammad (PBUH)**”. And according to the political philosophy of **Quaid-e-Azam Mohammad Ali Jinnah**.

For this purpose, the TNP is an association of citizens seeking to influence public opinion by participating in elections to the National, Provincial, District and Union Council level legislatures to fulfill its aims and objectives.

The Tajdeed-e-Nizam Party will seek the support of the pro-democracy forces and Awam Dost forces in the country to establish democracy at grass roots level, with a view to restore the rule of law, democracy, fundamental human rights as well as to seek the economic emancipation of the people.

The TNP will establish National, Provincial, District and Union Council level bodies.

PREAMBLE:

1. Whereas sovereignty over the entire Universe belongs to Almighty Allah Alone, and the authority to be exercised by the people of Pakistan within the limits prescribed by Him is a sacred trust;
2. And whereas it is the will of the people of Pakistan to establish an order;
3. Wherein the State shall exercise its powers and authority through the chosen representatives of the people;
4. Wherein the principles of Democracy, Freedom, Equality, Tolerance and Social Justice, as enunciated by Islam, shall be fully observed;
5. Wherein the Muslims shall be enabled to order their lives in the individual and collective spheres in accordance with the teachings and requirements of Islam as set out in the Holy Quran and Sunnah;
6. Wherein adequate provision shall be made for the minorities freely to profess and practice their religions and develop their cultures;
7. Wherein shall be guaranteed fundamental rights, including equality of status, of opportunity and before law, social, economic and political justice, and freedom of thought, expression, belief, faith, worship and association, subject to law and public morality.
8. wherein adequate provision shall be made to safeguard the legitimate interests of minorities and backward and depressed classes.
9. Wherein the independence of the judiciary shall be fully secured.
10. Wherein the integrity of the territories of the Federation, its independence and all its rights, including its sovereign rights on land, sea and air, shall be safeguarded;

11. So that the people of Pakistan may prosper and attain their rightful and honored place amongst the comity of nations and make their full contribution towards international peace and progress and happiness of humanity;
12. Now, therefore, we, the people of Pakistan Conscious of our responsibility before Almighty Allah and men;
13. Cognizant of the sacrifices made by the people in the cause of Pakistan. Faithful to the declaration made by the Founder of Pakistan, Quaid-e-Azam Mohammad Ali Jinnah, that Pakistan would be a democratic State based on Islamic principles of social justice;
14. Dedicated to the preservation of democracy achieved by the unremitting struggle of the people against oppression and tyranny.
15. inspired by the resolve to protect our National and Political unity and solidarity by creating an egalitarian society through a new and updated system.

CHAPTER-I

INTRODUCTORY

DEFINITIONS:

"Constitution" means the Constitution of "Tajdeed-E-Nizam Party" (TNP).

"Article" means an Article of the Constitution of "Tajdeed-E-Nizam Party" (TNP).

"Clause" means clause of the Article of this Constitution.

"Chairman" means the Chairman of "Tajdeed-E-Nizam Party" (TNP).

"Citizen" means a citizen of Pakistan as defined by the Citizenship Act, 1952.

NAME:

Name of the party will be "**Tajdeed-E-Nizam Party**". In abbreviation, it will be written as "**TNP**".

AIMS AND OBJECTIVES:

The aims & objectives of "Tajdeed-E-Nizam Party" (TNP) is to protect the rights of all Pakistanis irrespective of their race, religion and language. Some of the key objectives are;

PROTECTING RIGHTS:

TNP's primary objective is to safeguard the basic human rights of all citizens of Pakistan.

PROMOTING UNITY:

The second aim & objective of TNP is to promote unity among the citizens of Pakistan for peace, prosperity and development.

ESTABLISHING RELATIONS:

TNP also aims to establish relations among all communities and discourage politics on the basis of racism. The political objective is to shun politics of narrow nationalism and to encourage all citizens to become one Pakistani nation.

PROMOTING EDUCATION:

TNP will focus on spreading education & trainings among all citizens and will try to concentrate on less developed areas of Pakistan.

ESTABLISHING A NEW SYSTEM:

We will establish a new system where in both the haves and the haves-not will have equal opportunities.

CHAPTER-II

THE CENTRAL ORGANIZATION

CENTRAL TAJDEED-E-NIZAM:

For the whole country, there shall be a Tajdeed-e-Nizam Party (TNP) to be known as Central TNP and the area to be served by a Central TNP shall be co-extensive with the area of Centre for which it is constituted.

PARTY STRUCTURE:

The Central structure of the party shall consist of the following institutions:

1. Central Council (It will be an independent organ)
2. Central Executive Council
3. Central Cabinet
4. Central Parliamentary Party
5. General Assembly
6. Central Election Commission
7. Central Parliamentary Board

PARTY STRUCTURE PRINCIPLES:

Each institution of the party shall be organized on the basis that it shall:

1. Be of service to the masses in the field in which it operates.
2. Be responsible to inform and educate on all matters crucial for survival and advancement of the society and the country.
3. Provide a forum for debate on all local and national issues.
4. Enable public to be able to reach their elected representatives and party office bearers.
5. Identify, support, promote, and ensure the election of candidates who are the best to represent and implement the principles and values of TNP.
6. Be open, democratic and participative.
7. In so far as is practicable, and subject to the rules and the directives of the TNP Central Executive Council, each party institution shall be responsible for devising, administering and managing its own internal structures as per the constitution.

INSTITUTIONS ELABORATION

1) CENTRAL COUNCIL:

Central Council will comprise of 5 founding members who will initially elect a chairman as the head of Central Council ultimately being Chairman of the TNP.

POWERS AND FUNCTIONS OF THE CENTRAL COUNCIL:

The Central Council shall perform the following functions:

1. Approve or disapprove the policies devised by Central Executive Council.
2. Annual budget and expenses advised by Central Executive Council must be approved by the Central Council.
3. To approve the names of leaders for Senate, National Assembly, Provincial Assembly and District and Tehsil levels.

DURATION:

Duration of the members of the Central Council, except the chairman, will be 4 years. The duration of the chairman will be 5 years.

ELECTION:

I.) ELECTION OF THE MEMBERS

After the expiry of the first term of the Central Council, its 4 members will be elected by the Central Executive Council and the Central Cabinet combinedly. The four members shall be from all the four Provinces, i.e. one member from each province.

II.) ELECTION OF THE CHAIRMAN

While the Chairman of the party, who will also be chairman of the Central Council, will be elected combinedly by the Central Executive Council, Central Cabinet, Provincial Executive Councils of all the four (4) Provinces, Provincial Cabinets, Executive Council of the Islamabad Territory and Cabinet of the Islamabad territory.

This election will be held by the Central Election Commission, and it will chalk out its own way of conducting election.

2) CENTRAL EXECUTIVE COUNCIL:

The Central Executive Council shall be the supreme executive body of the Party.

The Chairman shall preside over meetings of the Central Executive Council.

FORMATION OF CENTRAL EXECUTIVE COUNCIL:

The Central Executive Council shall comprise of 17 elected members, four members from each Province and one member from the Capital Territory, besides members of the Central Cabinet. In addition, every Provincial President and Provincial General Secretary of each Province, President and General Secretary of the Capital Territory, and members of Parliament of the Party shall be ex-officio members of the Central Executive Council.

No office-bearer can be re-elected for the third time for the same office, after serving in it for two consecutive terms. However, the Central Council, by adopting the procedure for amendment/abrogation of the constitution, can exempt a person from this clause to take part in election for the same office for the third time.

MEETING OF CENTRAL EXECUTIVE COUNCIL:

The Central Executive Council shall hold, at least, four meetings in a year i.e. once after every three months. The Secretary General shall circulate notices and agenda of the meeting to the members. In case of emergency meeting, a five-day notice shall be compulsory.

QUORUM:

1/3rd members of the Central Executive Council shall constitute the quorum for its meetings.

PROCEDURE TO SUMMON URGENT MEETING:

1/4th members of the Central Executive Council can issue a notice to requisite a meeting, provided that agenda of the meeting is attached with the notice. The Secretary General shall convene a meeting of the Central Executive Council in consultation with the Chairman of the party within ten days (10) of the receipt of notice and agenda. The meeting shall have only the agenda, which was received with the notice.

PROCEDURE TO SUMMON EMERGENCY MEETING:

The Chairman of the party can issue a short notice to convene an emergency meeting. The Secretary General, on the advice of the Chairman, shall convene a meeting of the Central Executive Council from 24 to 72 hours.

In this case, agenda of the meeting will be presented during the meeting.

POWERS AND FUNCTIONS OF THE CENTRAL EXECUTIVE COUNCIL:

The Central Executive Council shall have the following powers and functions:

1. The Central Executive Council shall be the central executive body of the Party.
2. It will be subordinate to the Central Council and will be administered by the Central Council.
3. The Central Council can approve or dis-approve its decision.
4. The Central Executive Council will administer Provincial Executive Council, Provincial Parliamentary Parties, and Provincial Cabinets.
5. To devise policies and implement them in the light of the Party's manifesto.
6. To struggle for the implementation of Party's aims and objectives.
7. To gather all necessary information for the achievement of the aims and objectives of the Party and provide it to the members of the Central Executive Council.
8. To appoint sub-committees for the various functions of the Party.
9. To supervise the work of the sub-committees. To pass resolutions, in accordance with the Party's manifesto, and take steps for their implementation in the light of the aims and objectives of the Party and in view of the problems being faced by the people.
10. To prepare annual budget of the Party; approve income and expenditure and to audit the accounts of the Party by itself or through another institution.
11. To approve expenditures incurred by the Chairman and Secretary General in their discretion.
12. To perform all those functions approved by the Central Council.
13. To supervise the work of the Provincial Level Party and subordinate bodies and to take disciplinary actions against them as needed.
14. To take disciplinary action against a Party member and to give verdicts in appeals filed by members of the Party in decisions given in disciplinary action against them by Provincial level organs or lower organs of the Party.
15. To take an action against those members of the Central Executive Council who fail to attend three consecutive meetings of the Central Executive Council
16. To delegate powers or give directions to a member, office-bearer, committee or sub-committee of the Party.
17. Central Executive Council will act as the electoral board for the election of Central Election Commission Members.

ELECTION OF MEMBERS OF THE CENTRAL EXECUTIVE COUNCIL:

1. Initially, as the system is not developed and established fully, the members of the Central Executive Council shall be nominated by the Central Council.
2. After the expiry of the first term, the members will come through election.

3. The Central Election Commission will elect 4 members from each province and one member from the capital territory.
4. The Central Election Commission will elect members from the Provincial Executive Councils and the Provincial Cabinets to be members of the Central Executive Council. Members of the Provincial Executive Councils and the Provincial Cabinets will vote.
5. The members elected for the Central Executive Council will be no more members of the Provincial Executive Councils, and no more office bearer in the district.
6. The vacant seats created in the Provincial Executive Councils and Provincial Cabinets and the in the Districts shall be filled through an election, as usual for the Provincial/District institutions and cabinets, by the Provincial Election Commission.
7. After the election of Central Executive Council, the Provincial Election Commissions of each Province shall elect four members, within 30 days, for the vacant seats in the Provincial Executive Councils and in the District.
8. The Central Election Commission will chalk out its own way of conducting the Election.

3) CENTRAL CABINET:

The Central Cabinet shall comprise of the following office-bearers:

- A. Chairman
- B. President
- C. Senior Vice President
- D. 2 Vice Presidents (if necessary)
- E. Central Secretary General
- F. Secretary Information
- G. Secretary Finance
- H. Secretary Foreign Affairs
- I. Secretary Gender Equality and Women empowerment
- J. Secretary Labor
- K. Secretary Student Affairs
- L. Secretary Human Rights

Meetings of the Cabinet will be presided over by the Chairman of the TNP.

A) CHAIRMAN:

The Chairman shall be Head of the entire organization, the administrative and organizational head of the Party.

The Chairman of the TNP shall exercise all the powers inherent in his office and shall ensure that the Office- Bearers and TNP Institutions work in consonance with the TNP Constitution, rules, and any bye-laws adopted under it.

A.1) POWER AND FUNCTION OF THE CHAIRMAN

1. The Chairman can suspend a member or office-bearer of the Party on disciplinary measure, which shall be ratified by the Central Executive Council in its first meeting.
2. The Party Chairman can take a disciplinary action against a subordinate organ of the Party only with the approval of the Central Executive Council.
3. The Chairman shall preside over meetings of the Central Council, Central Executive Council and Central Cabinet.
4. Chairman may nominate any member of the party as Office Bearer(s) of the party till the election for the respective office(s) is held.
5. The Chairman may ask or appoint one or more Senior Vice President(s), and Vice Presidents to serve the President.
6. The Chairman may ask one of the Central Senior Vice Presidents/Vice Presidents to act as Acting President.
7. He/she may also appoint other Secretaries for specific subject.
8. He/she may appoint more Additional Secretary General (s), and Deputy Secretary Generals if so necessary.
9. He/she may also appoint a Chief Organizer to undertake organizational work of the Party.
10. The Chairman may appoint a special Committee from within the members of the Central Executive Council (CEC) to assist him in the exercise of his/her powers and discharge of his/her functions, and for this purpose he/she may entrust the Special Committee a specific task, regarding which implementation report shall be submitted to him for approval.
11. The Chairman may either himself sign party tickets for election to the Senate, National Assembly, Provincial Assembly, Local Government, including bye-elections, or may authorize in writing any other office bearer to do so.
12. The Chairman shall have the power of spending Rs. 500,000/- month at a time, details of which shall be provided by the Chairman to the Finance Committee.

A.2) ACTING CHAIRMAN:

During the temporary absence or illness of the Chairman or for any other reason, the Chairman may nominate the Central President or one of the Senior Central Vice Presidents or Central Vice Presidents to perform his functions temporarily for a specific period provided that the powers of forming, expanding, reshuffling or reconstituting the Central Council (CC), and the Central Executive Council (CEC), Central Cabinet or of nominating members of the Central Council shall not be exercisable by the Acting Chairman.

A.3) VACANCY OF THE OFFICE OF CHAIRMAN:

If the office of the Chairman falls vacant due to death or resignation or any other reason before the expiry of the term of his/her office, it shall be duty of the Secretary General to convene within seven days (07) a meeting of the Central Executive Council to elect an Acting Chairman. The power of the Acting Chairman will be according to the "Chapter-II-3-A.2". also, in that meeting the Central Executive Council will fix a date for the meeting of the General Assembly within 45 days of the occurrence of the vacancy to elect the Chairman.

A.4) ELECTION OF THE CHAIRMAN:

1. Initially the Chairman will be elected by the Central Council.
2. After the expiry of the first term, While the Chairman of the party, who will also be Chairman of the Central Council, will be elected combinedly by the Central Executive Council and Central Cabinet, Provincial Executive Councils and Provincial Cabinets of all the four Provinces, Executive Council and Cabinet of Islamabad Territory.
3. Duration of the Chairman will be 5 years.
4. The election for the post of Chairman will be held 6 months before the expiry of the duration of the post of Chairman.

B) CENTRAL PRESIDENT:

The post of the President is to assist the Chairman in discharge of his/her responsibilities, and make sure that the orders and recommendations of the Chairman have been implemented. Further, the President will try to implement, with the approval of the Chairman, the policies of the Central Executive Council.

POWER AND FUNCTION OF THE PRESIDENT:

1. The President at the Centre shall exercise such powers and perform such functions that are assigned to him/her by the Central Council and the Chairman.
2. President shall exercise all the powers inherent in his/her office and shall see that the office bearers and organization work in consonance with the Constitution of the Tajdeed-e-Nizam Party (TNP) and bye-laws adopted under the Constitution.
3. He / She will take all suitable measures and actions which are necessary to promote the Party and implement its aims and objectives.
4. He / She may advise the Chairman on any National or Political issue or matters relating to the party organization.
5. He / She will implement, only on written recommendation of the Chairman, the decisions of the Central Council, Central Executive council & their respective Committees.

6. He / She will decide the General complaints against the office bearers and members of the party and the decision will be send to central Executive committee.
7. If the Central Council or the Central Executive Council recommend, He / She will be able to establish committees consisting of party members to carry out various issues and entrust them with responsibilities and powers.
8. The duties of the President shall include the announcement and notification of the results of the Election Board.
9. **Duration** of the President will be 4 years.

B.1) ACTING PRESIDENT:

During the temporary absence or illness of the President or for any other reason, the Chairman may nominate the Central Senior Vice President or one of the Central Vice Presidents to perform his functions temporarily for a specific period.

His/her power and function will be limited as assigned by the Chairman.

B.2) ELECTION OF THE CENTRAL PRESIDENT:

1. Initially, as the system is not developed and established fully, The Central Executive Council shall nominate a person to be Central President, and will be sent to the Central Council for approval.
2. After the expiry of the first term, the Central President will come through election.
3. The Central Executive Council, the Central Cabinet and all the four
4. Provincial Presidents shall vote for the election of the Central President.
5. And the Election Commission will chalk out its own procedure of election.

C) SENIOR VICE PRESIDENT:

There will be one or two (if necessary) Senior Vice-President to assist the President in discharging his/her responsibilities. On the recommendation of the President, the Chairman may nominate one or two Senior Vice Presidents.

POWER AND FUNCTION:

The power and function of the Senior Vice president (SVP) will be specific according to the needs and circumstances, and assigned by the Chairman on the recommendation of the President.

D) VICE PRESIDENT:

There will be two or more (if necessary) Vice-Presidents to assist the Chairman, President and Senior Vice-President in discharging his/her responsibilities. The Vice President will be elected by the Central Executive Council. Then, On the recommendation of the President and the Chairman the Central Executive Council may elect one or two more Vice Presidents.

POWER AND FUNCTION:

The power and function of the Senior Vice president (SVP) will be specific according to the needs and circumstances, and assigned by the Chairman on the recommendation of the President.

E) CENTRAL SECRETARY GENERAL:

1. The Secretary General shall exercise all the powers delegated to him by the Chairman, Central Council or by the Central Executive Council.
2. Shall be responsible for keeping all records, files, papers and affairs of the Party's office.
3. Shall minutes all proceedings of the meetings and shall present it for approval in the next meeting.
4. Shall prepare annual reports, which shall be presented for approval in the meeting of the Central Council.
5. The Secretaries assigned different function shall assist the Secretary General and perform such duties under his guidance as may be entrusted to them.
6. Shall convene meetings of the Central Council, Central Executive Council and the Cabinet with the approval of the Chairman. Besides, he/ she shall, in consultation with the Chairman, call a meeting of the Central Council and the Central Executive Council by requisition demand of the members. He/ she shall prepare agenda for each meeting and shall provide to the concerned members.
7. Shall appoint, in consultation with the Chairman, office staff; determine terms and conditions of their service; and shall supervise and take disciplinary action against them, if so required.
8. Shall chalk-out a program to run the affairs of the Party in line with the Constitution and shall take approval from the Central Executive Council in this.

E.1) ELECTION OF THE SECRETARY GENERAL:

1. Initially, as the system is not developed and established fully, The Central Executive Council shall nominate a person to be Secretary General, and will be sent to the Central Council for approval.
2. After the expiry of the first term, the Secretary General will come through an election.
3. The Central Executive Council, the Central Cabinet, all the four Provincial Presidents and all the four Provincial General Secretaries shall vote for the election of the Central Secretary General.
4. And the election commission will chalk out its own procedure of election.

E-1) ADDITIONAL SECRETARY GENERAL-----If Necessary

There will be one or two Additional Secretary General, Deputy Secretary General and Assistant Secretary general (if necessary) to assist the Secretary General in discharging his/her responsibilities. On the recommendation of the Secretary General, the Chairman may nominate one or two Additional Secretary General.

E.2) ACTING SECRETARY GENERAL:

During the temporary absence or illness of the Secretary General or for any other reason, The Secretary General with the consent of the Chairman may nominate an Additional Secretary General, or Deputy Secretary General as acting Secretary General, and delegate any of his/her power(s) to the Additional Secretary General for a specific time period.

E.3) DEPUTY SECRETARY GENERAL:

The Deputy Secretary General(s) will assist the Secretary General/Additional Secretary General in his/her function.

E.4) ASSISTANT SECRETARY GENERALS-----If Necessary

Assistant Secretary General(s) will assist Secretary General, Additional Secretary General or Deputy Secretary General(s) in mobilization and organizational development.

F) INFORMATION SECRETARY:

The Information Secretary will communicate the views of the TNP. Information Secretary will be responsible for managing and disseminating information to the public and media. His/her function will be as follows.

1. He / She shall oversee the flow of information to ensure the public, media, and stakeholders are accurately informed about policies, decisions, and events.
2. He / She shall handle press releases, interviews, and briefings.
3. He / She Shall arrange press conferences as per directives of the Chairman and the Secretary General. Besides, shall be responsible for publication of the Party's manifesto and constitution.

4) CENTRAL PARLIAMENTARY PARTY:

Members of the National Assembly and senate, who have been elected to these bodies on party's tickets or joins the party after having been elected as member, shall form a Parliamentary Party in the Senate and National Assembly which shall elect its Parliamentary Leader and other office-bearers.

1. The Central Election Commission shall conduct the election of the Parliamentary Party leader, and other office bearers.
2. The Parliamentary Party shall be accountable before the Central Executive Council in the performance of its duties.

5) GENERAL ASSEMBLY:

1. The General Assembly will include elected members on District Level from every District of Pakistan, All Office Bearers at Central and Provincial level, Central Council Members, Central/Provincial Executive Council members and Central and Provincial Cabinet members and overseas Presidents and overseas General Secretaries.
2. Only Chairman of the party can convene a General Assembly meeting. Generally, its meeting shall be held after every 3 months given that the location of the meeting will be circulated along the Provinces of Pakistan. Chairman of the party will preside over the meeting.

FUNCTIONS OF GENERAL ASSEMBLY:

1. Its function will be to discuss overall situation in the country, Party Position, Challenges to the party and It will recommend policies to the Central Executive Council.

2. Central Executive Council has the power to either approve or reject its recommendations.

6) CENTRAL ELECTION COMMISSION:

1. The Central Electoral board for the election of members of the Central Election Commission will be Central Executive Council.
2. The Central Executive Council shall appoint a five-member election commission, which shall supervise Party elections in the entire country. The President of the commission shall be elected by its members themselves.
3. The Election Commission shall chalk out its own procedure for election.
4. Each Province shall have an equal representation in the Election Commission i.e. one member from each Province and one member from the Capital Territory.
5. It will conduct election for the Chairman, Central Council, Central Executive Council, Central President, Central Secretary General, Central Parliamentary party, after the expiry of the first term.
6. It can supervise all elections at Provincial levels.

6.1) CENTRAL ELECTION TRIBUNAL:

The Central Executive Council of the TNP shall appoint a Central Election Tribunal which may consist of three members. The Central Election Tribunal shall hear appeals and petitions against the Central Election Commission.

7) THE CENTRAL PARLIAMENTARY BOARD:

1. There shall be Central Parliamentary Board to be constituted by the Chairman.
2. The Central Parliamentary Board constituted or nominated shall function till the next General Elections. The Chairman may add or replace any member of the board.
3. The Chairman shall be President of the Board, and Provincial Presidents shall be members of the Board. A member of the Board shall be nominated to act as its Secretary.

7.1) FUNCTIONS OF THE BOARD:

The Central Parliamentary Board shall perform the following functions:

1. To select in consultation with the respective Provincial Parliamentary Boards candidates for general election or a bye- election to the seats in the Parliament/Assemblies.

2. To ensure that Provincial Parliamentary Boards are properly constituted in every Province as may be necessary and place their reports to the Central Parliamentary Board as may be necessary.
3. To supervise and control the activities of the Provincial Parliamentary Boards;
4. To hear and decide finally all appeals against the decisions of the Provincial Parliamentary Boards.
5. To approve rules and bye-laws framed by the Provincial Parliamentary Boards.
6. To frame bye-laws for the Central Parliamentary Board.
7. The Central Parliamentary Board may delegate any of its powers to its President to be exercised in case of emergency and with such limitations as may be considered necessary.
8. Five members shall form the quorum of a meeting of the Central Parliamentary Board.

CHAPTER-III

THE PROVINCIAL ORGANISATION

PROVINCIAL TAJDEED-E-NIZAM:

For each province of Pakistan, there shall be a Tajdeed-e-Nizam (TNP) to be known as Provincial TNP and the area to be served by a Provincial TNP shall be co-extensive with the area of Province for which it is constituted.

PROVINCIAL PARTY STRUCTURE:

The Provincial Party Structure shall consist of the following institutions:

1. Provincial Executive Council
2. Provincial Cabinet
3. Provincial Parliamentary Party
4. Provincial Parliamentary Boards
5. Provincial Election Commission

1) PROVINCIAL EXECUTIVE COUNCIL:

The Provincial Executive Council shall be executive body of the Party at Province level.

1.1) FORMATION OF THE PROVINCIAL EXECUTIVE COUNCIL

1. Provincial Executive Council will comprise of every party member elected as head on the district level from the respective Province. For example, Punjab Executive Council will comprise of elected members from districts as district head falling under the Punjab Province, besides members of the Provincial Cabinet. In addition, every Provincial President and Provincial General Secretary of each Province and members of Provincial Parliament (if exist) of the Party shall be ex-officio members of the Provincial Executive Council.
2. No office-bearer can be re-elected for the third time for the same office, after serving in it for two consecutive terms. However, the Central Council, by adopting the procedure for amendment/abrogation of the constitution, can exempt a person from this clause to take part in election for the same office for the third time.

1.2) MEETING OF THE PROVINCIAL EXECUTIVE COUNCIL:

1. The Provincial Executive Council shall hold, at least, four meetings in a year i.e. once after every three months. The Provincial General Secretary shall circulate notices and agenda of the meeting to the members. In case of emergency meeting, a five-day notice shall be compulsory.

2. Its meetings will be presided over by the Provincial President.

1.3) ELECTION OF PROVINCIAL EXECUTIVE COUNCIL:

All members of the Provincial Executive Council are already elected as head of the District of the concern Province.

2) PROVINCIAL CABINET:

The Provincial Cabinet shall comprise of the following office-bearers:

A) PROVINCIAL PRESIDENT:

The post of the Provincial President is to assist the Chairman in discharge of his responsibilities in Provincial level, and make sure that the orders and recommendations of the Chairman have been implemented. Further, the Provincial President will try to implement, with the approval of the Chairman, the policies of the Central Executive Council.

The Provincial President may appoint, with the approval of the Provincial Executive Council, one or more Vice Presidents, and one of them may serve as Senior Vice President. He may also appoint a Chief Organizer, with the approval of the Provincial Executive Council, to undertake organizational work of the Party, whenever necessary. In addition to the Information Secretary and Finance Secretary, the President may request for other secretaries, and the Provincial Executive Council may appoint other secretaries for different functions and more Additional General Secretaries, if necessary.

A.1) POWERS OF THE PROVINCIAL PRESIDENT:

1. The President of a Provincial TNP shall be the Head of the Provincial organization in the Province concerned and shall exercise all the powers inherent in his office and shall see that all the authorities in the Province of his jurisdiction work in consonance with the Constitution of the TNP, rules and bye-laws.
2. The Provincial President may appoint Provincial Committee(s) in consultation with the Chairman from within the members of the Provincial Executive

Council to assist him in the exercise of his powers and discharge of his functions and for this purpose may entrust to the Provincial Committee(s) specific tasks, regarding which implementation report shall be submitted to him/her for approval.

3. The Provincial President may sign party tickets with the approval of the Chairman for election to local bodies at all levels or may authorize in writing other office bearers to do so.

A.2) TERM OF OFFICE:

Every office-bearer shall hold office for a term of four years. He may resign from his office by a letter addressed to the President or the General Secretary. The vacancy in the office bearers shall be filled by the Provincial Executive Council of the Province concerned.

A.3) ELECTION OF THE PROVINCIAL PRESIDENT:

1. Initially, as the system is not developed and established fully, The Chairman shall nominate a person to be Provincial President of the concern Province, but it will be obligatory that this nomination will be approved by members of the Central Council through majority votes.
2. After the expiry of the first term, the Provincial President will come through election.
3. The Provincial Executive Council and Provincial Cabinet and all other Provincial office bearers will vote for the election of all the Provincial President and all office bearers.
4. And the Provincial Election Commission will chalk out its own procedure of election.

A.4) ACTING PRESIDENT

During the absence or illness, or for any other reason, the Provincial President, may nominate one of the Senior Vice Presidents or Vice Presidents to perform the functions of the President; Provided that the powers of forming, expanding, reshuffling or reconstituting the Provincial Executive Council of the Provincial TNP or of nominating members of other Provincial Institution, shall not be exercisable by any of the Acting Presidents.

A.5) VACANCY OF THE OFFICE OF PRESIDENT:

If office of the Provincial President falls vacant due to death, resignation or any other reason before the expiry of the term of his/her office, Chairman of TNP shall ensure the vacant position of the Provincial President is filled within 60 days by exercising one of the following two options:

- i. Chairman of TNP may direct the Provincial General Secretary to convene a meeting of the Provincial Executive Council to elect the new Provincial President within 60 days of such vacancy.

- ii. Chairman of TNP may nominate an Acting Provincial President. Once Provincial President has been nominated, the Provincial General Secretary shall convene a meeting of the Provincial Executive Council within 60 days for election of Provincial President.

D) PROVINCIAL GENERAL SECRETARY:

Duties of the General Secretary

1. The General Secretary shall exercise all the powers delegated to him by the Provincial Executive Council. The General Secretary shall exercise all powers and discharge all the duties laid down by and incidental to the enforcement of the Constitution and generally to his office.
2. The General Secretary shall supervise the work of the staff of the Provincial TNP Secretariat.
3. The General Secretary shall have the authority to grant leave of absence with or without pay to the staff and the authority to punish or suspend them, but all cases of dismissal shall be reported to the Provincial Executive Council.
4. In case of emergency and in the matters not affecting the fundamental principles of the Constitution, the General Secretary may, with the approval of the Chairman, take such actions on behalf of the Provincial TNP as he deems expedient. Provided that any action so taken shall be reported to the Provincial Executive Council at its next meeting for confirmation.

D.1) OTHER FUNCTIONARIES:

1. If the General Secretary needs one or more Additional/Deputy/Assistant General Secretaries to assist him/her in discharging his/her duties, he may request.
2. Until the Provincial Executive Council has been established, he/she will request to the Provincial President for the appointment of the above stated office bearers. The Provincial President will appoint the above office bearers only with the permission of the Chairman.
3. When there is Provincial Executive Council and functional, then the Provincial President will send the request to the Provincial Executive Council. The Provincial Executive Council may approve or reject the request.
4. All the Additional General Secretaries, Deputy General Secretaries, Joint General Secretaries shall assist the General Secretary and perform such functions under his guidance as may be entrusted to them.

D.2) ACTING GENERAL SECRETARY:

During the absence or illness of the General Secretary for any reason, the Provincial President, with the approval of the Central President, may nominate the Additional General Secretary or one of the Deputy or Joint Secretaries to act as Acting General Secretary. The General Secretary may delegate any of his/her power(s) to the Additional Secretary General for a specific time period for the smooth running of the party affairs.

D.3) ELECTION OF THE PROVINCIAL GENERAL SECRETARY:

1. Initially, as the system is not developed and established fully, The Chairman shall nominate a person to be Provincial General Secretary of the concern Province, but it will be obligatory that this nomination will be approved by members of the Central Council through majority votes.
2. After the expiry of the first term, the Provincial General Secretary will come through election.
3. The Provincial Executive Council and Provincial Cabinet and all other Provincial office bearers will vote for the election of the Provincial General Secretary and all other Provincial office bearers.
4. The Provincial Election Commission will chalk out its own procedure of election.

3) PROVINCIAL PARLIAMENTARY PARTY:

Member of the Provincial Assembly, who have been elected to the Provincial Assembly on Party's tickets or joins the Party after having been elected as members, shall form a Parliamentary Party in the province, which shall elect its own Parliamentary leader and other office-bearers. The Provincial Executive Council shall approve the election of the Parliamentary Party leader.

The Parliamentary Party shall be accountable before the Provincial Executive Council in the performance of its duties.

4) PROVINCIAL PARLIAMENTARY BOARDS:

There shall be a Provincial Parliamentary Board consisting of at least 12 members to be appointed by the Chairman TNP. The President of the Provincial TNP shall be President of the Parliamentary Board. The Board shall elect its own Secretary.

FUNCTIONS:

The Parliamentary Board shall perform the following functions:

1. To select the candidates for the Provincial Assemblies of the concerned Province in consultation with the respective District office bearers of the party.
2. To recommend names of the candidates for election to the Parliament/Assembly in consultation with respective district office bearers of the party for the consideration of the Central Parliamentary Board.
3. To see that TNP Parliamentary Parties are established in the Provincial Assemblies.
4. To frame rules and bye-laws for the Provincial Parliamentary Board. The Provincial Parliamentary Board may delegate any of its powers to the Chairman to be exercised in the case of urgency, subject to such limitations as may be deemed necessary.
5. One third members of the Provincial Parliamentary Board shall form the quorum of the meeting.

6. Any person aggrieved by the decision of the Provincial Parliamentary Board may prefer an appeal to the Central Parliamentary Board.

ELECTION OF THE PROVINCIAL OFFICE BEARERS:

1. Election of all Provincial office bearers shall be according to the rules of Provincial Election Commission, and shall be conducted by the provincial Election Commission, and supervised by the Central Election Commission.
2. Electoral board for all the Provincial office bearers will be Provincial Executive Council, Provincial Cabinet and all other office bearers.
3. The Provincial Election Commission will chalk out its own procedure of election.

5) PROVINCIAL ELECTION COMMISSION:

1. Provincial Executive Council will act as the electoral board for the election of Provincial Election Commission members.
2. The Provincial Executive Council shall constitute its own Election Commission, comprising of 5 members.
3. Three of whom shall be from all the three other Provinces other than the one in which elections are being held.
4. It will be called Provincial Election Commission.
5. It will chalk out its own way of conducting election according to the law.
6. It will conduct election of the President, the General Secretary and all other office-bearers.

FUNCTIONS:

The functions of the Provincial Election Commission shall be:

1. To supervise the Party elections at Province level, including at Provincial Parliamentary Party.
2. To supervise the Party elections at all District of the concerned Province.
3. To frame bye-laws for its working.

5.1) PROVINCIAL ELECTION TRIBUNAL:

1. The Provincial Executive Council of the Provincial TNP shall appoint a Provincial Election Tribunal which may consist of President of the Parliamentary board and two members.
2. The two members of the Tribunal shall be from two other Provinces.
3. The Provincial Election Tribunal shall hear appeals and petitions against the election to any tier of the party in a Province.

CHAPTER-IV

DISTRICT LEVEL PARTY

DISTRICT TAJDEED-E-NIZAM:

For each District of Pakistan, there shall be a Tajdeed-e-Nizam (TNP) to be known as District TNP and the area to be served by a District TNP shall be co-extensive with the area of District for which it is constituted.

DISTRICT PARTY STRUCTURE:

The District Party Structure shall consist of the following institutions:

1. District Executive Council
2. District Cabinet
3. District Election Commission.

1) DISTRICT EXECUTIVE COUNCIL:

The District Executive Council shall be executive body of the Party at District level.

1.1) FORMATION OF DISTRICT EXECUTIVE COUNCIL:

1. The District Executive Council of Tajdeed-e-Nizam Party shall consist of the representatives of Tehsils, Provincial Constituencies, and elected head of the Union Councils. Every Tehsil level head, and Union Council head falling in that District shall be member of District Executive Council of Tajdeed-e-Nizam Party. Besides, members of the District cabinet shall be members of the District Executive Council.
2. No office-bearer can be re-elected for the third time for the same office, after serving in it for two consecutive terms. However, the Provincial President, by adopting the procedure for amendment/abrogation of the constitution, can exempt a person from this clause to take part in election for the same office for the third time.

1.2) MEETING OF THE DISTRICT EXECUTIVE COUNCIL:

1. The District Executive Council shall hold, at least, six (6) meetings in a year i.e. once after every two months. The District General Secretary shall circulate notices and agenda of the meeting to the members. In case of emergency meeting, a five-days (5) notice shall be compulsory.
2. Its meetings will be presided over by the District President.

1.3) ELECTION OF DISTRICT EXECUTIVE COUNCIL

All members of the District Executive Council are already elected as head of the Tehsils & Union Councils of the concern District.

2) DISTRICT CABINET

The following shall be members of the Cabinet of the District TNP.

A.) DISTRICT PRESIDENT:

The President of District TNP shall be the Head of the District organization in the District concerned and shall exercise all the powers inherent in his office and shall see that all the authorities in the District of his/her jurisdiction work in consonance with the Constitution of the TNP, rules and bye-laws.

A.1) POWERS AND FUNCTION OF THE DISTRICT PRESIDENT:

1. The District President may ask or nominate one or more Vice Presidents to serve as Senior Vice President. He may also appoint a Chief Organizer at District level to undertake organizational work of the Party, whenever necessary. In addition to the District Information Secretary and District Finance Secretary, the District Executive Council, on the request of the District President, may appoint other secretaries for different functions and more Additional General Secretaries, if necessary.
2. The District President may appoint District Committee(s), in consultation with the Provincial President, from within the members of the District Executive Councils to assist him in the exercise of his/her powers and discharge of his/her functions and for this purpose may entrust to the District Committee(s) specific

tasks, regarding which implementation report shall be submitted to him/her for approval.

A.2) TERM OF OFFICE:

Every office-bearer shall hold office for a term of four years. He may resign from his office by a letter addressed to the Provincial President or the Provincial General Secretary. The vacancy in the office bearers shall be filled by the District Executive Council of the District concerned.

A.3) ACTING PRESIDENT:

During the absence or illness, or for any other reason, the District President, may nominate one of the District Senior Vice Presidents or District Vice Presidents to perform the functions of the District President; Provided that the powers of forming, expanding, reshuffling or reconstituting the District Executive Council of the District TNP or of nominating members of other District Institutions, shall not be exercisable by any of the Acting Presidents.

A.4) VACANCY OF THE OFFICE OF PRESIDENT:

If office of the District President falls vacant due to death, resignation or any other reason before the expiry of the term of his/her office, Provincial President of TNP shall ensure the vacant position of the District President is filled within 30 days by exercising one of the following two options:

- i. Provincial President of TNP may direct the District General Secretary to convene a meeting of the District Executive Council to elect the new District President within 30 days of such vacancy.
- ii. Provincial President of TNP may nominate an Acting District President. Once District President has been nominated, the District General Secretary shall convene a meeting of the District Executive Council within 30 days for election of District President.

A.5) ELECTION OF THE DISTRICT PRESIDENT:

1. Initially, as the system is not developed and established fully, The Provincial Presidents, in their own Provinces, shall nominate a person to be District President of the concern District, but it will be obligatory that these nominations will be approved by the Central President.
2. After the expiry of the first term, the District President will be elected by the District Executive Council, District Cabinet and all other office bearer at the District level through an election conducted by the Provincial Election Commission.

3. And the Provincial Election Commission will chalk out its own procedure of election.
4. The District President will preside over meetings of District Executive Council.

D.) DISTRICT GENERAL SECRETARY:

D.1) Duties of the District General Secretary

1. The District General Secretary shall exercise all the powers delegated to him by the District Executive Council. The District General Secretary shall exercise all powers and discharge all the duties laid down by and incidental to the enforcement of the Constitution and generally to his office.
2. The District General Secretary shall supervise the work of the staff of the District TNP Secretariat.
3. The District General Secretary shall have the authority to grant leave of absence with or without pay to the staff, and the authority to punish or suspend them, but all cases of dismissal/suspension shall be reported to the District Executive Council. In the case of dismissal, it will be approved by the District Executive Council.

D.2) OTHER FUNCTIONS:

1. If the District General Secretary needs one or more Additional/Deputy/Assistant General Secretaries to assist him/her in discharging his/her duties, he/she may request;
2. Until the District Executive Council has been established, he/she will request to the District President for the appointment of the above stated office bearers. The District President will appoint the above office bearers only with the permission of the Provincial President.
3. When there is District Executive Council and functional, then the District President will send the request to the District Executive Council. The District Executive Council may approve or reject the request.
4. All the Additional General Secretaries, Deputy General Secretaries, Joint General Secretaries shall assist the General Secretary and perform such functions under his/her guidance as may be entrusted to them.

D.3) ACTING DISTRICT GENERAL SECRETARY:

During the absence or illness of the General Secretary for any reason, the District President, with the approval of the President, may nominate the Additional General Secretary or one of the Deputy or Joint Secretaries to act as acting General

Secretary. The General Secretary may delegate any of his/her power(s) to the Additional General Secretary for a specific time period for the smooth running of the party affairs.

D.4) ELECTION OF THE DISTRICT GENERAL SECRETARY:

1. Initially, as the system is not developed and established fully, the Provincial President and the Provincial General Secretary will combinedly nominate a person to be District General Secretary of the concern District, but it will be obligatory that this nomination will be approved by Central President.
2. After the expiry of the first term, the District General Secretary will be elected by the District Executive Council, District Cabinet and all other district office bearers through an election conducted by the District Election Commission.
3. And the District Election Commission will chalk out its own procedure of election.

D.5) ELECTION OF THE DISTRICT OFFICE BEARERS:

1. Election of all District office bearers shall be according to the rules of District Election Commission, and shall be conducted by the District Election Commission, and supervised by the Provincial Election Commission.
2. Electoral board for all the District office bearers will be District Executive Council, District Cabinet and all other office bearers.

3.) DISTRICT ELECTION COMMISSION:

1. District Executive Council will act as the Electoral Board for the election of District Election Commission members.
2. The District Executive Council shall constitute its own election commission, comprising of 5 members. Three of the five members shall be residents of other District.
3. it will be called District Election Commission.
4. It will chalk out its own way of conducting election according to the law.
5. It will conduct election of the, the General Secretary and all other office-bearers.
6. All elections at District level will be supervised by the Provincial Election Commission.

CHAPTER-V

UNION COUNCIL LEVEL PARTY

UNION COUNCIL (UC) TAJDEED-E-NIZAM PARTY (TNP):

For each Union Council (UC) of Pakistan, there shall be a Tajdeed-e-Nizam Party (TNP) to be known as Union Council (UC) TNP.

PARTY STRUCTURE:

The Union Council (UC) Party Structure shall consist of the following institutions:

1. Union Council (UC) Executive Council
2. Union Council (UC) Sub-Executive Council
3. Union Council (UC) Social Forum Council
4. Union Council (UC) Cabinet
5. Union Council (UC) Election Commission
6. Union Council Disputes Resolution Committee (DRC)

5. UNION COUNCIL (UC) EXECUTIVE COUNCIL:

1.4) Formation of the Union Council Executive Council:

- i. The Union Council Executive Council of Tajdeed-e-Nizam Party shall consist of the representatives of TNP at all Mohallas level that falls in that Union Council. It will be called Union Council Executive Council of Tajdeed-e-Nizam Party. Besides, all member of the Union Council cabinet will be members of the Union Council Executive Council.
- ii. No office-bearer can be re-elected for the third time for the same office, after serving in it for two consecutive terms. However, the District Executive Council, by adopting the procedure for amendment/abrogation of the constitution, can exempt a person from this clause to take part in election for the same office for the third time.

1.5) MEETING OF THE UC EXECUTIVE COUNCIL:

- i. The Union Council Executive Council shall hold meeting at the end of every month. The Union Council General Secretary shall circulate notices and agenda

of the meeting to the members. In case of emergency meeting, 2 days' notice shall be compulsory.

- ii. Its meetings will be presided over by the Union Council President.

1.6) ELECTION OF THE MEMBERS OF THE UNION COUNCIL EXECUTIVE COUNCIL:

- i. All members of the Union Council Executive Council are already elected as head of the Mohallas of the concern Union Council.
- ii. The President of the concern Union Council will be President of the Union Council Executive Council.
- iii. Its meeting will be presided over by the President.

6. UNION COUNCIL (UC) SUB-EXECUTIVE COUNCIL:

6.1) Formation:

- i. The Union Council President of the TNP, Union Council General Secretary of the TNP and only the TNP representatives at Mohalla levels be member of the Sub-Executive Council.
- ii. The President of the concern Union Council will be president of the Union Council Sub-Executive Council.
- iii. Its meeting will be presided by the concern Union Council President of the TNP.

6.2) FUNCTION OF THE UC SUB-EXECUTIVE COUNCIL:

Its main function will be to elect members of the Social Forum Council at the concern Union Council level by the majority of votes. The social activist should be residents of the concern Union Council.

Followings will be the social/welfare activist:

- a) General Social Worker
- b) Human Rights Activist
- c) Practicing Lawyer
- d) Religious Scholar
- e) Labour Rights Activist
- f) Representative of minorities (religios + kaspian)
- g) Representative of Agricultural land-owners
- h) Land-Tillers
- i) Activist against the debt-slavery

7. UNION COUNCIL (UC) SOCIAL FORUM COUNCIL:

3.1) Formation:

Following will be members of the Union Council Social Forum:

- a) Union Council President
- b) Union Council General Secretary
- c) General Social Worker
- d) Human Rights Activist
- e) Practicing Lawyer
- f) Religious Scholar
- g) Labour rights activist
- h) Representative of minorities (religious + Craftsmen (KASAB GHAR))
- i) Representative of agricultural land-owners
- j) Land-tillers
- k) Activist against the debt-slavery

3.2) FUNCTION:

Its function will be to discuss, resolve and find out solution for all the social issues in different fields facing by residents of the concern Union Council.

3.3) MEETING:

The Union Council General Secretary will call meeting of the Social Forum Council once in two weeks. However, if there is an urgent issue or emergency, the General Secretary can call its meeting anytime.

Its meeting will be presided over by the Union Council President.

4.A) UNION COUNCIL PRESIDENT:

The President of Union Council TNP shall be the Head of the Union Council organization in the Union Council concerned and shall exercise all the powers inherent in his office, and shall see that all the authorities in the Union Council of his / her jurisdiction work in consonance with the Constitution of the TNP, rules and bye-laws.

4.A.1) POWERS OF THE UNION COUNCIL PRESIDENT:

1. The Union Council President may appoint Union Council Committee(s), in consultation with the District President, from within the members of the Union Council Executive Council to assist him in the exercise of his / her powers and discharge of his / her functions and for this purpose may entrust to the Union Council Committee(s) specific tasks, regarding which implementation report shall be submitted to him / her for approval.
2. The Union Council President may ask or nominate one or more Vice Presidents to serve as Senior Vice President. He may also appoint a Chief Organizer at Union Council level to undertake organizational work of the Party, whenever necessary. These nominations must be approved by the Union Council Executive Council. In addition to the Union Council Information Secretary and Union Council Finance Secretary, on the request of the Union Council President, the Union Council Executive Committee may appoint other secretaries for different functions and more Additional General Secretaries, if necessary.

4.A.2) TERM OF OFFICE:

Every office-bearer shall hold office for a term of four (4) years. He may resign from his office by a letter addressed to the District President or the District General Secretary. The vacancy in the office bearers shall be filled by the Union Council Executive Council of the concerned Union Council.

4.A.3) ACTING UC PRESIDENT:

During the absence or illness, or for any other reason, the District President, may nominate one of the Senior Vice Presidents or Vice Presidents to perform the functions of the Union Council President; Provided that the powers of forming,

expanding, reshuffling or reconstituting the Union Council Executive Council of the Union Council TNP or of nominating members of other Union Council Institutions, shall not be exercisable by any of the Acting Presidents.

4.A.4) VACANCY OF THE OFFICE OF UC PRESIDENT:

If office of the Union Council President falls vacant due to death, resignation or any other reason before the expiry of the term of his/her office, District President of TNP shall ensure the vacant position of the Union Council President is filled within 30 days by exercising one of the following two options:

- I. District President of TNP may direct the Union Council General Secretary to convene a meeting of the Union Council Executive Council to elect the new Union Council President within 30 days of such vacancy.
- II. District President of TNP may nominate an Acting Union Council President. Once Union Council President has been nominated, the Union Council General Secretary shall convene a meeting of the Union Council Executive Council within 30 days for election of Union Council President.

ELECTION OF THE UC PRESIDENT:

1. Initially, as the system is not developed and established fully, The District President, in their own District, shall select a person to be acting Union Council President of the concern Union Council. When the Executive Council at District level get established, this selection will be approved by the District Executive Council.
2. After the expiry of the first term, the Union Council President will be elected by the Union Council Executive Council, Union Council Cabinet and all other office bearers at the Union Council level through an election conducted by the Union Council Election Commission.
3. The Union Council election commission will chalk out its own procedure of election.
4. The District Election Commission may supervise this election.

4.D) UNION COUNCIL (UC) GENERAL SECRETARY:

4.D.1) Duties of The UC General Secretary:

1. The Union Council General Secretary shall exercise all the powers delegated to him by the Union Council Executive Council. The Union Council General Secretary shall exercise all powers and discharge all the duties laid down by and incidental to the enforcement of the Constitution and generally to his office.

2. The Union Council General Secretary shall supervise the work of the staff of the Union Council TNP Secretariat.
3. The Union Council General Secretary shall have the authority to grant leave of absence with or without pay to the staff, and the authority to punish or suspend them, but all cases of dismissal/suspension shall be reported to the Union Council Executive Council. In the case of dismissal, it will be approved by the Union Council Executive Council.

4.D.2) OTHER FUNCTIONS:

- a) If the Union Council General Secretary needs one or more Additional/Deputy/Assistant General Secretaries to assist him/her in discharging his/her duties, he/she may request;
- b) Until the Union Council Executive Council has been established, he/she will request to the Union Council President for the appointment of the above stated office bearers. The Union Council President will appoint the above office bearers only with the permission of the District President.
- c) When there is Union Council Executive Council and functional, then the Union Council President will send the request of the Union Council General Secretary to the Union Council Executive Council. The Union Council Executive Council may approve or reject the request.
- d) All the Additional General Secretaries, Deputy General Secretaries, Joint General Secretaries shall assist the Union Council General Secretary and perform such functions under his/her guidance as may be entrusted to them.

4.D.3) ACTING UC GENERAL SECRETARY:

During the absence or illness of the Union Council General Secretary for any reason, the Union Council President, with the approval of the District President, may nominate the Additional General Secretary or one of the Deputy or Joint Secretaries to act as Acting Union Council General Secretary. The General Secretary may delegate any of his/her power(s) to the Acting General Secretary for a specific time period for the smooth running of the party affairs.

4.D.4) ELECTION OF THE UC GENERAL SECRETARY:

1. Initially, as the system is not developed and established fully, The District President, in their own District, shall select a person to be acting as Union Council General Secretary of the concern Union Council. When the Executive Council at District Level get established, this selection will be approved by the District Executive Council.

2. After the expiry of the first term, the Union Council General Secretary will be elected by the Union Council Executive Council and Cabinet through an election conducted by the Union Council Election Commission.
3. This election will be conducted by the Union Council Election Commission.
4. The Union Council Election commission will chalk out its own way of conducting election.

5.) UNION COUNCIL (UC) ELECTION COMMISSION:

1. Union Council (UC) Executive Council will act as the electoral board for the election of Union Council Election Commission Members.
2. The Union Council Executive Council shall constitute its own Election Commission, comprising of 5 members. Three of the five members shall be residents of other Union Councils.
3. It will be called Union Council Election Commission.
4. It will chalk out its own way of conducting election according to the law.
5. It will conduct election of the President, the General Secretary and all other office-bearers.
6. All elections at Union Council level will be supervised by the District Election Commission.

6.) UNION COUNCIL (UC) DISPUTES RESOLUTION COMMITTEE (DRC)

When there are disputes/ conflicts among the residents of the concern Union Council, (DRC) will try to resolve their disputes/conflicts amicably.

The Union Council Executive Council shall select some social activists for the formation of this committee. It is not necessary that these social activists will be member of the TNP or residents of the concern Union Council. In this case, the TNP does not want any credit for itself, but just want to resolve the disputes and establish a peaceful atmosphere. Because peaceful atmosphere is the first and foremost condition for the progress in every field.

CHAPTER-V

INTERNATIONAL AFFAIRS & OVERSEAS PAKISTANI'S PARTY

Tajdeed-e-Nizam Party always acknowledges and serves our overseas diaspora. Their welfare and rights, including representation, grievances, will be its one of the priorities.

ORGANIZATIONAL STRUCTURE:

The President of International Affairs and Overseas Pakistanis shall be in charge of Overseas organization and shall appoint all the office bearers of Overseas organization in consultation with the Chairman of the TNP.

The following shall be the office bearers of the Central Overseas Organization:

1. President overseas ONE
2. Senior Vice President(s) As may be necessary
3. General Secretary ONE
4. Finance Secretary
5. Chief Coordinator
6. Coordinator(s) -----(for continents, region or country) As may be necessary.
7. Any other office as may be deemed necessary by the President International Affairs and Overseas Pakistanis to achieve the objectives of the Organization

The President International Affairs and Overseas Pakistanis can set up TNP branches in each country / city.

overseas branches will function on the pattern of a Provincial TNP and, for that purpose, the provisions of the relevant rules shall, mutatis mutandis apply. Variations may be made to suit local conditions with the approval of President International Affairs and Overseas Pakistanis.

MEMBERSHIP:

Membership fee in each country will be fixed periodically by its country branch office, which will also determine the manner in which these funds are utilized.

All Overseas branches shall be affiliated with the Central Organization of TNP and shall function under the control and supervision of the Chairman.

ORGANIZING COMMITTEE:

In countries, where the TNP branch needs to be organized, the Chairman in consultation with the President International Affairs and Overseas Pakistanis may appoint an Organizing Committee to establish the Overseas branch of TNP and to hold elections at the appropriate time.

REPRESENTATION ON CENTRAL BODIES:

The Presidents and General Secretaries from each Country shall be member of the General Assembly Convention of the TNP and shall have the power to nominate another member to represent them in the Convention.

1. Subscription fee of the overseas branches of TNP shall be decided by the Chairman TNP in consultation with the President International Affairs and Overseas Pakistanis, and funds thus generated shall be properly maintained, accounted and utilized with approval of President International Affairs and Overseas Pakistanis.
2. Party will not receive/accept aid or contribution, financial or otherwise, from any foreign government or political party of a Foreign Country or any portion of its funds from Foreign National.
3. Membership drive will be widened by each country President subject to approval of President International Affairs and Overseas Pakistanis.
4. Membership fee and overseas funds account will be set up and maintained under the command and control of the President International Affairs and Overseas Pakistanis and accounted to Chairman TNP.

CHAPTER-VI

PARTY ELECTION

ELECTIONS PROCEDURE:

All members in good standing and discipline who subscribe to the aims of the TNP will be eligible to contest for the offices of the TNP.

All office-bearers of the Central Executive Council, Central Cabinet and all other Party office-bearers at Centre, Provinces, Districts and Union Councils (UC) shall be elected for a period of 4 years. However, they shall perform functions till next Party Elections shall take place at the Central, Provincial and District and Union Councils (UC) level.

(A) CENTRAL ELECTION COMMISSION:

FORMATION:

1. The Central Electoral board for the election of members of the Central Election Commission will be Central Executive Council.
2. The Central Executive Council shall appoint a five-member Election Commission.
3. Each Province shall have an equal representation in the Election Commission i.e. one member from each Province and one member from the Capital Territory.
4. The President of the commission shall be elected by its members themselves, and be called "President of Central Election Commission".

FUNCTION:

1. It shall conduct all elections of the TNP at Center Level.
2. Apart from elections at Center Level, it shall supervise Party elections in the entire country.
3. It can advise Election Commissions in Provinces, districts and Union Councils.
4. The Central Election Commission shall chalk out its own procedure for conducting election.
5. It will conduct elections for the Chairman, Central Council, Central Executive Council, Central President, Central Secretary General, Central Parliamentary party etc. after the expiry of the first term.
6. It shall elect all office bearers at the center level if it deems necessary.

(A-a) CENTRAL ELECTION TRIBUNAL:

The Central Executive Council of the TNP shall appoint a Central Election Tribunal which may consist of three members. The Central Election Tribunal shall hear appeals and petitions against the Central Election Commission:

(A-1) ELECTION OF THE CENTRAL COUNCIL:

1. After the expiry of the 1st term of the Central Council, its 4 members will be elected by the Central Executive Council and the Central Cabinet combinedly. The four members shall be from all the four provinces, i.e., one member from each Province.
2. The election shall be conducted by the Central Election Commission.
3. After the expiry of the first term, While the Chairman of the party, who will also be chairman of the Central Council, will be elected combinedly by the Central Executive Council and Central Cabinet, Provincial Executive Councils and Provincial Cabinets of all the four Provinces, Executive Council and Cabinet of Islamabad Territory.
4. This election will be held by the Central Election Commission, and it will chalk out its own way of conducting election.
5. Duration of the members of the Central Council, except the Chairman, will be 4 years. The duration of the chairman will be 5 years.

(A.2) ELECTION OF THE CENTRAL EXECUTIVE COUNCIL:

1. Initially, as the system is not developed and established fully, the members of the Central Executive Council shall be nominated by the Central Council.
2. After the expiry of the first term, the members will come through election.
3. The Central Election Commission will elect 4 members from each province and one member from the Capital Territory.
4. The Central Election Commission will elect members from the Provincial Executive Councils and the Provincial Cabinets to be members of the Central Executive Council. Members of the Provincial Executive Councils and the Provincial Cabinets will vote.
5. The members elected for the Central Executive Council will be no more members of the Provincial Executive Councils, and no more office bearer in the District.
6. The vacant seats crated in the Provincial Executive Councils and Provincial Cabinets and the in the Districts shall be filled through an election, as usual for the Provincial/District institutions and cabinets, by the Provincial Election Commission.
7. After the election of Central Executive Council, the Provincial Election Commissions of each province shall elect four members, within 30 days, for the vacant seats in the Provincial Executive Councils and in the District.

8. The Central Election Commission will chalk out its own way of conducting the Election.

(A.3) ELECTION OF THE CHAIRMAN:

1. Initially the chairman will be elected by the Central Council.
2. After the expiry of the first term, While the Chairman of the party, who will also be chairman of the Central Council, will be elected combinedly by the Central Executive Council and Central Cabinet, Provincial Executive Councils and Provincial Cabinets of all the four Provinces, Executive Council and Cabinet of Islamabad Territory.
3. Duration of the Chairman will be 5 years.
4. The election for the post of Chairman will be held 6 months before the expiry of the duration of the post of Chairman.

(A.4) ELECTION OF THE CENTRAL PRESIDENT:

1. After the expiry of the first term, the Central President will come through election.
2. The Central Executive Council, the Central Cabinet and all the four Provincial Presidents shall vote for the election of the Central President.
3. And the Central Election Commission will chalk out its own procedure of election.

(A.5) ELECTION OF THE SECRETARY GENERAL:

1. Initially, as the system is not developed and established fully, The Central Executive Council shall nominate a person to be Secretary General, and will be sent to the Central Council for approval.
2. After the expiry of the first term, the Secretary General t will come through election.
3. The Central Executive Council, the Central Cabinet, all the four Provincial Presidents and all the four Provincial General Secretaries shall vote for the Election of the Central Secretary General.
4. And the Election Commission will chalk out its own procedure of election.

(A.6) ELECTION OF CENTRAL OFFICE BEARERS:

Election of all central office bearers shall be according to the rules of Central Election Commission, and shall be conducted by the Central Election Commission.

The Central Executive Council and Central Cabinet and all other Central office bearers will vote for the election of all the Central office bearers.

The Central Election Commission shall chalk out its own way of conducting election.

(B.) PROVINCIAL ELECTION COMMISSION:

FORMATION:

1. The Provincial Electoral board for the election of members of the Provincial Election Commission will be Provincial Executive Council.
2. The Provincial Executive Council shall appoint a five-member Election Commission.
3. Three out of the five members shall be from other three Provinces, and two members from the Province in which election is being held.
4. It will be called Provincial Election Commission.
5. The President of the commission shall be elected by its members themselves, and be called "President of Provincial Election Commission".

FUNCTIONS:

The functions of the Provincial Election Commission shall be:

- i. It will chalk out its own way of conducting election according to the law.
- ii. It will conduct election of the Provincial President, the Provincial General Secretary and all other office-bearers.
- iii. To supervise the Party Elections at Provincial level, including Provincial Parliamentary Party.
- iv. To supervise the Party elections at all District of the concerned Province.
- v. To frame bye-laws for its working.

B.b) PROVINCIAL ELECTION TRIBUNAL:

The Provincial Executive Council of the TNP shall appoint a Provincial Election Tribunal which may consist of three members. The Provincial Election

B.1) ELECTION OF THE MEMBERS OF THE PROVINCIAL

EXECUTIVE COUNCIL:

All members of the Provincial Executive Council are already elected as head of the Districts of the concern Province.

(B.2) ELECTION OF THE PROVINCIAL PRESIDENT:

1. Initially, as the system is not developed and established fully, The Chairman shall nominate a person to be Provincial President of the concern Province, but it will be obligatory that this nomination will be approved by members of the Central Council through majority votes.
2. After the expiry of the first term, the Provincial President will come through election.
3. The Provincial Executive Council and Provincial Cabinet and all other Provincial office bearers will vote for the election of all the Provincial office bearers.
4. And the Provincial Election Commission will chalk out its own procedure of election.

(B.3) ELECTION OF THE PROVINCIAL GENERAL SECRETARY:

1. Initially, as the system is not developed and established fully, The Chairman shall nominate a person to be Provincial General Secretary of the concern Province, but it will be obligatory that this nomination will be approved by members of the Central Council through majority votes.
2. After the expiry of the first term, the Provincial General Secretary will come through election.
3. The Provincial Executive Council and Provincial Cabinet and all other Provincial office bearers will vote for the election of the Provincial General Secretary and all other Provincial office bearers.
4. And the Provincial Election Commission will chalk out its own procedure of election.

(B.4) ELECTION OF PROVINCIAL OFFICE BEARERS:

1. Election of all the Provincial office bearers shall be according to the rules of Provincial Election Commission, and shall be conducted by the Provincial Election Commission.
2. The Provincial Executive Council and Provincial Cabinet and all other Provincial office bearers will vote for the election of all the Provincial office bearers.

3. And the Provincial Election Commission will chalk out its own procedure of election.

(C) DISTRICT ELECTION COMMISSION:

FORMATION:

1. The District Electoral board for the election of members of the District Election Commission will be District Executive Council.
2. The District Executive Council shall appoint a five-member Election Commission.
3. Three out of the five members shall be from other three District, and two members from the District in which election is being held.
4. It will be called District Election Commission.
5. The President of the commission shall be elected by its own members themselves, and be called “President of District Election Commission”.

FUNCTION:

1. It shall conduct all elections of the TNP at District level.
2. Apart from elections at District level, it shall supervise Party Elections in the entire District.
3. It can advise Election Commissions in Union Councils.
4. The District Election Commission shall chalk out its own procedure for conducting election.
5. It will conduct elections for the District Executive Council, District President, District General Secretary.
6. It shall elect all office bearers at the District level if it deems necessary.
7. It will chalk out its own way of conducting election according to the law.
8. All elections at District level will be supervised by the Provincial Election Commission.

C.1) ELECTION OF THE DISTRICT PRESIDENT:

1. Initially, as the system is not developed and established fully, The Provincial Presidents, in their own Provinces, shall nominate a person to be District president of the concern District, but it will be obligatory that these nominations will be approved by the Central President.
2. After the expiry of the first term, the District President will be elected by the District Executive Council, District Cabinet and all other office bearer at the District Level through an election conducted by the Provincial Election Commission.

3. And the Provincial Election Commission will chalk out its own procedure of election.
4. The District President will preside over meetings of District Executive Council.

C.2) ELECTION OF THE DISTRICT GENERAL SECRETARY:

1. Initially, as the system is not developed and established fully, the Provincial President and the Provincial General Secretary will combinedly nominate a person to be District General Secretary of the concern District, but it will be obligatory that this nomination will be approved by Central President.
2. After the expiry of the first term, the District General Secretary will be elected by the District Executive Council, District Cabinet and all other district office bearers through an election conducted by the District Election Commission.
3. Election of the District General Secretary conducted by the District Election Commission will be supervised by the Provincial Election Commission.
4. And the District Election Commission will chalk out its own procedure of election.

C.3) ELECTION OF DISTRICT OFFICE BEARER:

4. Election of all District office bearers shall be according to the rules of District Election Commission, and shall be conducted by the District Election Commission, and supervised by the Provincial Election Commission.
5. Electoral board for all the District office bearers will be District Executive Council, District Cabinet and all other office bearers.

(D) UNION COUNCIL (UC) ELECTION COMMISSION:

FORMATION:

1. The Union Council Electoral board for the election of members of the Union Council Election Commission will be Union Council Executive Council.
2. The Union Council Executive Council shall appoint a five-member Election Commission.
3. Three out of the five members shall be from other three Union Council, and two members from the Union Council in which election is being held.
4. It will be called Union Council Election Commission.
5. The President of the Election commission shall be elected by its own members themselves, and be called “President of Union Council Election Commission”.

FUNCTION:

1. It shall conduct all elections of the TNP at Union Council level.
2. The Union Council Election Commission shall chalk out its own procedure for conducting election.
3. It will conduct elections for the Union Council Executive Council, Union Council President, Union Council General Secretary.
4. It shall elect all office bearers at the Union Council level if it deems necessary.
5. All elections at Union Council level will be supervised by the District Election Commission.

(D.1) ELECTION OF THE UC PRESIDENT:

1. Initially, as the system is not developed and established fully, The District President, in their own district, shall select a person to be acting Union Council President of the concern Union Council. When the Executive Council at District level get established, this selection will be approved by the District Executive Council.
2. After the expiry of the first term, the Union Council President will be elected by the Union Council Executive Council, Union Council Cabinet and all other office bearers at the Union Council level through an election conducted by the Union Council Election Commission.
3. The UC election commission will chalk out its own procedure of election.
4. The district election commission may supervise this election.

(D.2) ELECTION OF THE UC GENERAL SECRETARY:

1. Initially, as the system is not developed and established fully, The District Presidents, in their own district, shall select a person to be acting as Union Council General Secretary of the concern Union Council. When the Executive Council at District level get established, this selection will be approved by the District Executive Council.
2. After the expiry of the first term, the Union Council General Secretary will be elected by the Union Council Executive Council through an election.
3. This election will be conducted by the Union Council Election Commission.
4. The Union Council Election Commission will chalk out its own way of conducting election.

(D.3) ELECTION OF UNION COUNCIL OFFICE BEARERS:

Election of all Union Council office bearers shall be according to the rules of Union Council Election Commission, and shall be conducted by the Union Council Election Commission, and supervised by the District Election Commission.

CHAPTER-VII

MEMBERS ELIGIBILITY AND TERMINATION

1.) ELIGIBILITY OF MEMBERSHIP:

All Pakistani citizens, inside the Pakistan Territory are eligible to take membership of TNP on the condition that they support and accept the aims and objectives of this Party and are committed to work within the constitution and rules of TNP.

Membership forms and other data entry requirements along with membership fees will be required for full membership of TNP.

Any person who supports the aims of the TNP to build a society in conformity with the vision as stated above, while being desirous of contesting the general elections and subsequent general and bye-elections on TNP parliamentarian's ticket with a view to promote its aims is eligible for membership.

2.) OVERSEAS MEMBERSHIP:

- a) All Overseas branches shall be affiliated with the central organization of TNP and shall function under the control and supervision of the Chairman.
- b) Membership fee in each country will be fixed periodically by its country branch office, which will also determine the manner in which these funds are utilized.

3.) MEMBERSHIP FEE:

Each member shall pay basic membership fee of

1. Rs. 500 per annum for the citizens who live in Pakistan.
2. Rs. 5000 per annum for the citizens who live abroad.
3. Elected members will pay an annual fee of amount Rs.10,000/annum.
4. Apart from, the members can donate fund of any amount to the party for a special public gathering, or special purposes.
5. This fee/fund will be collected by the Finance Secretary and/or officers designated from time to time by the Chairman.
6. This amount of fund can vary from time to time on the instruction of Central Executive Council.

4.) AUDIT:

The received/collected fund from the members will be audited at least once at the end of every year by the committee chosen by the Central Executive Council.

5.) TERMINATION:

Each member will accept the decisions of the TNP in a disciplined fashion even when the view may be contrary to their own personal opinion including differences

relating to suspension, termination and expulsion. To defy the decision of the Party is violation of the conditions of membership. Members committing indiscipline cease to be members of the TNP.

Those violating the conditions for eligibility of the “Tajdeed-E-Nizam Party” will cease to be members of the party.

5.A) PROCEDURE FOR TERMINATION:

If, a party member, or any office bearer, made violation(s) of the party’s discipline, policy, rules and regulations, disciplinary action will be taken against them. A showcase notice will be issued by the concern Provincial General Secretary. The reply of the showcase notice along with accusations will be forwarded to;

- 1) The Provincial Executive Council, If the violator is just a member of the TNP. The Provincial Executive Council will decide about the termination of the accused member.
 - 1.1) If the Provincial Executive Council decides to expel a party member, then he/she has the right to appeal, within 30 days, against the decision to the Central Executive Council, which will make the decision. The decision of Central Executive Council will be final.
- 2.) The Provincial Executive Council, If the violator is an office bearer of the TNP. The Provincial Executive Council will decide about the termination of the accused member.
 - 2.a) If the Provincial Executive Council decides to expel a party member, then he/she has the right to appeal, within 30 days, against the decision to the Central Executive Council, which will make the decision. But in this case, the approval of the Central Council is necessary. Then, the decision of Central Executive Council’s decision will be final.

CHAPTER-VIII

RESOLUTION OF DISPUTE

A) DISPUTE BETWEEN A MEMBER AND THE TNP:

A member is free to give their opinion on the TNP forum remembering that differences in opinion are a matter of democratic free will subjected to the subordination to the framework of the Party.

Political parties are associations of people for a particular aim.

When a dispute arises, including differences relating to suspension and expulsion.

1. If the dispute is between a member and the TNP party, then the case will be forwarded to the Provincial Executive Council (PEC) through Provincial Secretary General. The Provincial Secretary General will try to resolve the differences. If the Provincial Secretary General failed to resolve the differences, then it can terminate his/her basic membership from the party in the larger party interest. Then the terminated member can appeal, within 30 days, against this decision to the Central Executive Council (CEC). Here the decision will be final.
2. If the dispute is between an office-bearer and the TNP party, then the case will be forwarded to the Central Executive Council (CEC) through Central Secretary General. The Central Executive Council will try to resolve the differences. If the Central Executive Council failed to resolve the differences, then it can terminate his/her basic membership from the party in the larger party interest. Then the terminated office-bearer can appeal, within 30 days, against this decision to the Central Council (CC). Here the decision will be final.

B.) Dispute between Member and Member:

Efforts will be made to reconcile members by the office bearers. The Provincial Executive Council (PEC) may establish a committee to bring about such reconciliation. The TNP at different levels can make rules for reconciling differences from time to time including differences relating to suspension and expulsion.

CHAPTER-IX

DURATION AND RESIGNATION

B.) DURATION OF THE OFFICE BEARERS:

1. The term of office for the organization shall be four (4) years.
2. While the duration of the term for Chairman is five (5) years. The election for the post of Chairman will be held 6 months before the expiry of the duration of the post of Chairman.
3. The process for the election of the organization shall be commenced one hundred and twenty days (120) before the expiry of the term.
4. The process of the election shall be concluded Thirty (30) days before the expiry of the term.
5. The chairman of the TNP may, after consultation with the Central Executive Council, extend the term of office of any particular institutions or particular office bearers in an extraordinary situation.

B.) RESIGNATION:

An office bearer may resign from his/her office and such resignation may be addressed to the concord President or Secretary General/ General Sectary of the TNP, as the case may be.

CHAPTER-X

CENTRAL WINGS COMMITTEES

- 1) Secretary Foreign affairs
- 2) Judicial Reforms Committee
- 3) Human Rights committee
- 4) Labour Rights & uplifts committee
- 5) kissan welfare committee
- 6) Trade promotion committee
- 7) Ulema and Mashaikh committee
- 8) Secretary Gender equality and Women Empowerment
- 9) Secretary Student
- 10) Secretary Labor Affairs

1. SECRETARY FOREIGN AFFAIRS:

He/ she shall be responsible for affairs of the Party in foreign countries and shall be answerable to the Central Executive Council.

2. JUDICIAL REFORMS COMMITTEE:

This committee will comprise of retired judges and practicing lawyers. Its members will be nominated by Central Executive Council and elected by lawyers and judges who are members of the party. It shall organize contacts, meetings with the lawyers at center, Provincial and District level. Its main function will be to suggest reforms in judiciary for the welfare of the people.

3. HUMAN RIGHTS COMMITTEE:

The Human Rights Committee is the body of independent rights expert that monitors implementation of national human rights and International Covenants on Civil and political rights by the State, Government and its machineries.

The Committee's work will be to promote the enjoyment of civil and political rights, this may result in change of law, policy and practice.

It will strive to ensure the enjoyment of all civil and political rights, without any discrimination, by all people as guaranteed by the Constitution of the Islamic Republic of Pakistan and the Covenant.

Its members shall be independent rights experts, retired judges and lawyers of national reputation and independent rights activist.

4. LABOUR RIGHTS & UPLIFTS COMMITTEE:

Labour Rights and uplift committee will strive to protect workers' rights, improve labour laws and promote fair working conditions at Central, Provincial, District and Union Council levels.

5. KISSAN / LAND-TILLERS WELFARE COMMITTEE:

Kissan welfare committee will focus on the rights, welfares and upliftment of farmers (kissan) and land-tillers. This committee will aim to address issues like agricultural development, fair pricing, subsidies, farmer's rights and especially the rights of land-tillers, the exploitation of the land-tillers by the land lords.

Its members will be farmers, land-tillers and organizations who strive for the rights of land-tillers.

6. TRADE PROMOTION COMMITTEE:

The main function of this committee will be to boost export, trade and business. It will create an environment of economic activities.

Its members will be head of different business and trade associations, trade and business experts at academic level, and retired officials who have long and practical experience in international trade.

7. ULEMA AND MASHAIKH COMMITTEE:

The Ulema and Mashaikh Committee shall strive to promote religious harmony, peace and social unity. It will try to unite Ulema and Mashaikh of different school of thoughts on a single platform to develop a common strategy on national issues.

This committee shall try to create an environment of teaching Quran to people.

8. SECRETARY GENDER EQUALITY AND WOMEN EMPOWERMENT:

He/ she shall keep contacts with Women federations and shall organize the subordinate organ of the Party in the women and shall supervise their activities.

Only Women will be eligible for this post.

9. SECRETARY STUDENT:

He/ she shall keep contacts with student federations and shall organize the subordinate organ of the Party in the students and shall supervise their activities.

10. SECRETARY LABOR AFFAIRS:

He / she shall keep contacts with labor federations and shall organize the subordinate organ of the Party in the labours and shall supervise their activities.

CHAPTER-XI

FINANCE

A.) FINANCE:

Fund from any national or foreign or multi-national public or private firms or business companies, trade companies or from any National or International NGOs, or any Professional Associations will not be accepted.

B.) SECRETARY FINANCE:

He will open the Party bank account accordingly and will maintain it. He will collect membership fees from the members of the TNP.

He will also collect fees from members of the Executive Councils and Committees. Each member of the Central, Provincial and District Executive Councils and Committees will pay an annual fee of Rs. 12,000/-, except in case of exemption.

If an executive member failed to pay the due fee in-time, his/her post will be suspended for a specific time period. Again, if he/she failed to pay the fee in suspended period, he/she will lose his/her post from that Executive Councils or committee.

Shall deposit all cash in the Bank Account.

Shall keep a proper record of the income and expenditure of the Party and shall audit such the accounts of the Party.

CHAPTER-XII

MISCELLANEOUS

1.) AMENDMENTS IN THE CONSTITUTION:

The Constitution of TNP may be amended by the General Assembly of the TNP by majority of the members present and voting on the recommendation of Central Executive Council, which will approve the proposed recommendations by majority members present and voting.

2.) DECISIONS BY MAJORITY VOTE:

All matters shall be decided by majority of votes.

3.) POWERS TO MAKE RULES:

The Chairman shall, with the approval of the Central Executive Council, make rules for carrying out the purposes of the Constitution.

4.) REMOVAL OF DIFFICULTY:

If any difficulty arises in giving effect to any of the Provisions of the Constitutions, the Chairman TNP may make such Provisions for the removal of the difficulty as he may deem fit.

5.) OFFICE-BEARERS TO HOLD OFFICE TILL ELECTION:

If the term of an office-bearer, a member of a Committee or any other body of TNP expires, he/she shall continue to perform his/her duties as such till his/her successor in office is elected, or as the case may be, nominated by the competent authority unless left vacant for any reason.

6.) MEMBERSHIP OF PARLIAMENTARY PARTY FOR INDEPENDENT MEMBERS:

Independent Members of the Parliament or Provincial Assemblies may become members of the TNP Parliamentary Party in the Parliament or as the case may be, in a Provincial Assembly by signing a pledge to the effect that they shall abide by the decisions or orders of the Parliamentary Party of TNP from time to time.

7.) DISPUTES RESOLUTION COMMITTEE:

If any dispute arises between member and party on Principles or aims or laws or rules and objectives of the party, the matter will be referred to 3 member's committee constituted by the Party Chairman or the Central Executive Council.

8.) PERFORMANCE REPORTS:

All Central office bearers and Provincial Organizations shall forward performance report to the Party Chairman every quarter for presentation to Central Executive Council through Secretary General. Likewise, all District organizations and Provincial office bearers shall present performance report to respective Provincial President for presentation to Provincial Executive Councils through respective General Secretary.

- I. No office bearer of the party will hold office in the service of Pakistan and party offices at a time.
- II. A member or group of members of the party may nominate in writing any other member/group of the party as delegate to represent him or them and cast his/their vote in party meeting:
- III. Provided that the so nominated member/members must be the member of that forum. The nominator must inform the party President and Secretary General/General Secretary in writing with his signature 5 days prior to the meeting with the name/names of the delegate.
